23 of 45 survey respondents, expressed they have a Protected Characteristic that disadvantaged them.

Comments from those who identify as having a Protected Characteristic:

The over 50's Table tennis club meet at the Grange on Tuesday, Thursday and Friday. It is the best over 50's club in Central Scotland and a centre for table tennis in the area. The size and quality of the facility for table tennis will be very difficult to replace. The fact that there are three different sessions per week mean that at least one session is suitable for most and some, like myself can attend three mornings per week. It's great exercise for me personally and also very important socially as I live on my own and there are very few opportunities for me to socialise with such a friendly group of people. I would really miss it and I'm sure that my mental health would deteriorate without this. I'm sure many of the people who go would say the same. Table tennis is great exercise and good for the mind too.

Daughter attends table tennis club. She suffers from autism and the club has been a god send to her in her development.

The Grange Centre provides a huge variety of activities, including child care, that benefit the community. The over 50s clubs, for example, provide support for physical and mental health issues and are thriving. To lose these facilities would be a local disaster and have severely detrimental affects in users if all ages.

No other facilities for older people to engage in this sport in the area.

Venue for the largest Junior table tennis group in the Falkirk area with over 30 members aged 7-17. If the venue was no longer available we would struggle to find another suitable venue able to host our equipment and sessions.

Grange Community Education Centre has been the base of the Grange Table Tennis Club for several years whose players are mostly veterans and play not only in the local Stirlingshire Table Tennis League but also in Scottish and International Competitions representing Scotland.

I play table tennis at the Grange and it has been a saviour in terms of my physical and mental health, with no other options nearby.

"This is the only local group for children and adults with Downs Syndrome, run by a branch of downs syndrome Scotland.

This is a much needed facility to allow families to get together and receive advice and support as their child grows up.

The children and adults with downs syndrome are able to socialise with each other and not feel as alone in society."

"Our Activities club for people with Down's syndrome of all ages have been meeting here for almost 30 years and find the facilities ideal for our varied needs.

My children attend the Grange After School Project which uses the Grange Centre to provide after school care for children of working parents.

We run a men's group that helps to tackle social isolation and loneliness in the deprived area of Grangemouth. If we no longer had access to the building our group would need to disband and the attendees mental health would take a heavy tole causing further stress on other services.

Yes. My children attend after school club at that venue. There is a huge shortage of childcare in my neighbourhood: if this after school school club wasn't an option I would have to reduce my working hours as I have no other childcare option. As far as I know, there is no other possible venue in my neighbourhood to accommodate this after school club.

"Closure of the building would impact on after school childcare. There is no other building in the area that the Grange After School Club could move to, to continue to provide this service. This would mean that I as the mum would not be able to work anymore. Employers in my profession do not allow 3pm pick ups and afternoon childcare at home. Part time jobs are very difficult to obtain in my profession.

We make extensive use of the Grange After School Project for our childcare needs. Both myself and my husband work and having an affordable childcare programme within walking distance of both school and our home is required. Previously we were unable to find childminders that were able to look after our child in the area due to limited spaces - I cannot drive so pickup is difficult if it is too far away from Wallacestone School. Without the support of the Grange After School Project it is likely myself or my husband would have to stop work.

Comments from those who do not identify as having a Protected Characteristic but have made comments on impact of closure on those who do:

It would be a disaster to close down The Grange as we use it 5 times a week for two different table tennis clubs as we are all over 50 years of age up to one man who is 95.

I use this facility 2/3 times each week, it is a highly valued facility which provides the Community with a sporting place for the older members of the Community to meet, to play sport and to maintain friendships and positive wellbeing. I would find this devastating if this facility closed both from a physical and mental wellbeing perspective.

Furthermore, my son is disabled, has autism and epilepsy. The afterschool service is crucial for his social development and has sufficient expertise to handle him and his medication. The Grange After School Project operating out of this building is the only service available to my son. I strongly feel that closure of the building will discriminate working mums because of childcare issues and children with disabilities and special needs due to lack of other services."

If the centre closed, I would be out of a job. This would cause huge strain on me financially. I have a 4year old child as a single parent I am the only source of income

My Child uses this for after school care without this facility I cannot work and care for my child

Losing the Centre and GASP would have a significant impact on me and partner but most of all it would impact my child. GASP has a large amount of children of mixed ages and my child enjoys interacting and socializing with the other children. The group has a lot of equipment stored at the Grange which is used by my child. In addition the Grange has great facilities such as a ball court for sports activities and a kitchen which allows the group to prepare snacks for the children. The grange is also within walking distance from the school which keeps my child active.

My son attends the Grange After School Project at the centre 2 days a week. This is the only after school club available for children attending Wallacestone Primary school and allows working parents to have a safe and fun environment for their children to attend after school to allow them to remain in employment and work 'normal' hours. Without this facility, there would be nowhere for them to go. There are no other facilities locally that I believe would have the space and facilities that the Grange centre does to allow it to run. There would not be sufficient childminders in the area to accommodate all of the children who attend GASP and this would mean that parents may need to change hours at work which would mean a cut in salary. A cut in salary would mean that they may not be able to afford household costs and that they would have less money to spend in the local economy.
