Comments from those who identify as having a Protected Characteristic:

Due to my disability I enjoy attending some of the local groups and activities that take place in Slamannan community education centre. If the centre closes this would severely impact my mental health and I would become socially isolated.

This is a small community already quite far from any other village or facility also with a restricted bus service which leaves us isolated.

"As an area that is already in the bottom 20% in the Scottish Index of Multiple Deprivation, Slamannan as a rural community is further disadvantaged in relation to resources and local amenities. The impact of which are outlined in the Rural Deprivation evidence summary commissioned by Sot Gov in 2016.

Falkirk Council's Local Outcome Improvement Plan has clear themes and outcomes:

- working in partnership with communities
- poverty
- mental health and wellbeing

- substance use
- gender based violence
- economic recovery

Closing the community centre is in direct conflict with all of these outcomes and will further exacerbate the isolated and disproportionately disadvantaged residents of Slamannan."

"This the only community centre of this type within 8 miles. Slamannan is an area of deprivation and closure of this asset will result in an already marginalised society being unfairly targeted.

Hallglen Centre has recently been closed and there is nowhere else for children to attend."

The community centre is a huge part of Slamannan and the only place our residents have to be able to have classes and groups without this. centre Slamannan has absolutely nothing and will lose its only social networking place.

My future.

Unless the groups can transfer to other buildings, I don't believe there is any support.

There is nothing which could mitigate this situation as it is about scale of space and its availability which cannot be replicated elsewhere.

Reject closure of community centre. Look at improving services, perhaps relocating the library to the community centre to share overheads. Proper engagement with community to formulate a development plan.

"This is why I pay council tax, it is for the council to work out how to provide facilities, not the public.

I note with interest the income for the centre last year £740. I can only assume this is an accounting error as there are several groups that attend weekly. The school attend regularly, are they being charged for usage..."

Keeping our centre open and in good repair.

Where Has The Money Gone?

Comments from those who do not identify as having a Protected Characteristic but have made comments on impact of closure on those who do:

Personally I feel that there are a multitude of factors that should be taken into account before making the decision. I feel it would be helpful for the community if the library was perhaps moved into the community center, if perhaps there was a member from the council within Slamannan community center to support the tenants of this area as it is classed as a village in poverty.

I don't think the building should be closed there is nothing else in the village. Martha's pantry is excellent for many families also bring library in to centre.

The pantry is a well needed Resource here, with the cost of living crisis our community rely on this service. Some people don't even have the bus fares to reach other places. By removing the centre you really are making us the forgotten village".

"My children and wife use this centre 3/4 times a week. It is a needed resource in this area for an all ready poverty stricken area. We already have a reduced bus service which stops us being able to do many activities outside of Slamannan. The children of Slamannan need this as they have nothing to do which leads to vandalism and increase crime rates, I'm sure the police force could do without that. The school also has very little clubs for the kids or activities. In fact after school the only one availability for an hour is basketball.

The closure of this facility would mean that there would be no place for the youth clubs that are attended. The food pantry would have to be else where and this would make it very difficult for me personally. Slamannan is already classes as a village in need and by taking away one of the very few resources available for the community, it will undoubtedly have a large impact.
